CONSTRUCTION CORPORATION FOR A DEVELOPMENT PROJECT KNOWN

AS "PROMENADE AT EAST WINDSOR"

WITNESSETH

WHEREAS, PAREC CONSTRUCTION CORPORATION (hereinafter the "Developer") is the owner of a parcel of land located within the Township of East Windsor with an address of 671 Route 33, East and more particularly described as Block 14, Lots 977 on the Official Tax Map of the Township of East Windsor consisting of 9.67 acres; and

WHEREAS, the Developer has submitted to the EAST WINDSOR MUNICIPAL UTILITIES AUTHORITY (hereinafter "Authority" or "EWMUA") for approval Plans and Specifications for the construction of certain water and sanitary sewer facilities to be located on and in the vicinity of Block 14, Lot 977 on the Official Tax Map of the Township of East Windsor for providing sanitary sewer and water service to that development known as "Promenade at East Windsor" (the "Development"), consisting of a mixed use commercial/retail shopping center of 91,462.13 square feet on approximately 9.67± acres, more particularly described on plans entitled "Major Site Plan Drawings for the Promenade at East Windsor, Sheets 1-17, prepared by Sharif H. Aly, P. E." prepared by Ameritech Engineering, dated April 01, 2013, with latest revisions dated November 20, 2019, and consisting of 17 sheets, as approved by the Authority ("Approved Plans and Specifications") and any other governmental entity having jurisdiction thereover; and

WHEREAS, the Planning Board of the Township of East Windsor ("Approving Board" or "Board") granted amended preliminary site plan approval by Resolution No. 2017-16 on July 27, 2017 and memorialized on September 25, 2017 for the subject property; and

WHEREAS, the Developer and the Authority desire to enter into an agreement setting forth the rights, duties and obligations of the parties in connection with the construction of the water and sanitary sewer utility improvements related to said Development, including off-tract improvement obligations of the Developer, with certain conditions attached to the EWMUA's approval, as set forth

more fully below.

NOW, THEREFORE, BE IT RESOLVED BY THE EAST WINDSOR MUNICIPAL UTILITIES

AUTHORITY as follows:

1. The EWMUA hereby approves the Capacity Allocation

Agreement and Developer's On-Tract and Off Tract Improvement

Agreement with PAREC CONSTRUCTION CORPORATION, and

2. The EWMUA directs the EWMUA Chairperson and Secretary to

execute the aforementioned Agreement on behalf of the EWMUA and cause the same to be delivered to

the Developer and all other parties having jurisdiction in this matter, and

3. The EWMUA directs that the Executive Director shall take all necessary steps to expedite the

directions specified in this resolution, as appropriate, and

4. The approval of the Capacity Allocation Agreement and Developer's On-Tract and Off-Tract

Agreement between the parties is accompanied by certain specific conditions of approval also written

within the Agreement, as follows:

Condition One: NJDEP Approval of All Capacity Allocations by EWMUA is required.

Condition Two: If required by the NJDEP, proof of authorization to connect any adjoining property owner,

sewer or water systems shall be provided.

This resolution shall take effect immediately.
