WHEREAS, in accordance with a properly advertised Notice to Bidders, four (4) bidders submitted bids for the provision of Sludge Hauling Service which were received on October 14, 2020

WHEREAS, pursuant to the Quantities @ section on page PIB 9 of the Bid Specifications the East Windsor Municipal Utilities Authority may award a contract for one (1) or two (2) years; and

WHEREAS, after review of the bids submitted there was one (1) low bidder:

- 1) Russell Reid Co., 200 Smith Street, Keasbey, NJ 08832 for the provision of Sludge Hauling Service from East Windsor MUA to Stony Brook RSA in 2021 at \$0.0279 per gallon and in 2022 at \$0.0299 per gallon.
- 2) Freehold Cartage, Inc., 825 Highway 33, PO Box 5010, Freehold NJ 07728 for the provision of Sludge Hauling Service from East Windsor MUA to Somerset Raritan Valley Sewerage Authority in 2021 at \$0.0406 per gallon and 2022 at \$0.0406 per gallon.

WHEREAS, it is the recommendation of the Executive Director that Russell Reid Co. be awarded the contract for the provision of Sludge Hauling Service for two (2) years from East Windsor to Stony Brook RSA as the lowest responsible bidder; and

WHEREAS, it is the recommendation of the Executive Director that Freehold Cartage, Inc. be awarded the contract for the provision of Sludge Hauling Service for two (2) years from East Windsor to Somerset Raritan Valley Sewerage Authority as the lowest responsible bidder; and

WHEREAS, East Windsor Municipal Utilities Authority went to public notification to accept bids for the purpose of drilling a pilot well located at 146 Millstone Road also known as the Pollution Control Facility on October 7, 2020; and

WHEREAS, the East Windsor Municipal Utilities Authority ("Authority") has determined the need for a new water treatment plant and during the planning stage must drill a pilot well to do a complete study by obtaining a full geophysics sampling of the soils and a complete water quality sampling of the aquifer; and

WHEREAS, in accordance with a properly advertised Notice to Bidders by the provisions of the New Jersey Local Public Contracts Law, *N.J.S.A.* 40A:11-1 *et seq.*, two (2) bidders submitted bids for the provision of Pilot Well Boring which were received on November 5, 2020; and

WHEREAS, in soliciting bids for said work, the Authority followed the Fair and Open process in accordance with *N.J.S.A.* 19:44A-20.4; and

WHEREAS, after review of the two (2) bids submitted there was one (1) low bidder:

1) A.C. Schultes – 664 South Evergreen Avenue, Woodbury Heights, NJ 08097 - \$23,425 for the for the drilling of the pilot well and Geophysics sampling of the soil. Alternate bid #1 - \$4,700.00 water quality analysis. Alternate Bid #2 – 2,000.00 for Abandon/seal pilot well for a total Bid of \$30,125.00.

WHEREAS, it is the recommendation of the Executive Director that A.C. Schultes be awarded the contract for the provision of Pilot Boring/Monitoring Well Construction and Water Quality Sampling bid as the lowest responsible bidder; and

WHEREAS, the Financial Officer has certified that sufficient funds are available for the award of these contracts; and

RESOLUTION AUTHORIZING THE IMPLEMENTATION OF CERTAIN PROJECTS THAT QUALIFY FOR THE OFF - TRACT IMPROVEMENT FUND (OTIF) TO BE INCLUDED INTO THE UPDATED OTIF TABLES

RESOLUTION NO. 2020-43

WHEREAS, the East Windsor Municipal Utilities Authority ("Authority") has determined through its Asset Management Plan and the increase in development in the Township of East Windsor that the Off Tract Improvement Fund (OTIF) tables included in the Authority's Rules and Regulations need to be updated to reflect future improvements not yet constructed as well as improvements that need upgrading to be able to continuously and adequately serve the Authority's rate payers with water and sewer; and

WHEREAS, the Authority has power and authority pursuant to the Municipal and County Utilities Authorities Law (N.J.S.A. 40:14B-1 et seq.) and other legal sources, including the Authority's Rules and Regulations, to require Developers to install both on-tract and off-tract facilities and infrastructure necessary to secure adequate service from the common water and sanitary sewer facilities of the Authority; and

WHEREAS, the Authority has determined that certain existing facilities and infrastructure has exceeded its capacity and that developers connecting to such facilities and infrastructure are required to pay their proportionate share either to install new infrastructure relieving/expanding those existing facilities or providing new facilities; and

WHEREAS, The Authority shall determine the extent to which a developer will be required to pay an OTIF or construct certain off-tract improvements in lieu of such payment, based in part upon the findings as contained in the Utilities Master Plan, dated May 14, 1992, as well as the Authority's Asset Management Plan as may be from time to time amended; and

WHEREAS, the Executive Director and the Authority Engineers have determined several other projects qualify as improvements for the OTIF and shall be included in the updated OTIF tables for future development; and

WHEREAS, the existing and new improvements are set forth in the table attached hereto as Exhibit A; and

NOW THEREFORE, BE IT RESOLVED by the East Windsor Municipal Utilities Authority as follows:

- 1. That the Executive Director, with the advice and input of the Authority's Engineer, is hereby authorized and directed to include the projects listed above in the OTIF tables along with the proportionate cost sharing to be applied to future development that connects to or utilizes these facilities and infrastructure;
 - 2. That this Resolution shall take effect immediately;
