RESOLUTION AUTHORIZING THE ACCEPTANCE OF A MAINTENANCE GUARANTEE POSTED BY LAKE DRIVE PROPERTIES, LLC FOR THE 30 LAKE DRIVE DEVELOPMENT

RESOLUTION NO. 2023 - 23

WHEREAS, Lake Drive Properties, LLC received approval from the East Windsor Township Planning Board for a development known as "30 Lake Drive" consisting of a warehouse to be constructed on Block 20.01, Lots 18.01 East Windsor Township Tax Map; and

WHEREAS, said development required both sanitary sewer and water service from the East Windsor Municipal Utilities Authority; and

WHEREAS, Lake Drive Properties, LLC entered into a Capacity Allocation and Developers On-Tract and Off-Tract Agreement wherein a maintenance guarantee was required to be posted to ensure the maintenance of the connection to the Authority's 12-inch water main associated with 30 Lake Drive; and

NOW, THEREFORE, BE IT RESOLVED by the East Windsor Municipal Utilities Authority as follows:

- The Developer acknowledges that he has posted a Maintenance Guarantee pursuant to the Rules and Regulations of the Authority, in the amount of \$12,924.00 in cash.
- 2. Pursuant to the procedures established in the Rules and Regulations of the Authority, said sum shall be used as a source of payment for any monies for the repair or replacement of improvements to the water connection for 30 Lake Drive, for a period of two (2) years from the date of the adoption of the Resolution accepting said Maintenance Guarantee.
- 3. At the expiration of the two (2) year period herein described, the Authority shall, by formal resolution, release the Maintenance Guarantee herein described to the Developer, provided that the Authority ascertain that the permitted improvements for which the Maintenance

Guarantee has been posted are acceptable. Said release of said Maintenance Guarantee shall be provided in accordance with the Rules and Regulations of the Authority.

- 4. In the event that the cost for the maintenance exceeds the amount deposited by the Developer herein, the Developer shall be required to pay the Authority any excess monies expended by the Authority to maintain said permitted improvements during the term of this Agreement.
- 5. In the event that any charge is made against the Maintenance Guarantee established during the two (2) year period hereof, the Developer agrees to reestablish the Maintenance Guarantee in the full amount thereof until its release.
