WITNESSETH

WHEREAS, THE PLACE AT EAST WINDSOR, LLC (hereinafter the "Developer") is the contract purchaser of parcels of land located within the Township of East Windsor more particularly described as Block 5, Lot 2.02 on the Official Tax Map of the Township of East Windsor; and

WHEREAS, the Developer has submitted to the East Windsor Municipal Utilities Authority (hereinafter "Authority" or "EWMUA") for approval Plans and Specifications for the construction of certain water, sanitary sewer and fire service improvements to be located on and in the vicinity of Block 5, Lot 2.02 on the Official Tax Map of the Township of East Windsor for the development known as "The Place at East Windsor" (the "Development"); and

WHEREAS, the Developer has submitted to the Authority for approval Plans and Specifications for the construction of certain sanitary sewer and water facilities to be located on the Property to provide sanitary sewer and water service to a proposed residential development known as "The Place at East Windsor" (the "Project"), which will include fifty six (56) affordable housing apartments in three (3) buildings containing three (3) stories each, being more particularly described and identified on plans entitled, "Preliminary

and Final Site Plan For The Place at East Windsor, Township of East Windsor, Mercer County, New Jersey Block 5 Lot 2.02," prepared by Menlo Engineering Associates Inc, dated February 15, 2019 with latest revisions dated October 5, 2023, approved by the Authority ("Approved Plans and Specifications"); and

WHEREAS, the Planning Board of the Township of East Windsor ("Planning Board") granted the Developer Preliminary and Final Site Plan approval for the Project on April 1, 2019, which approval was memorialized in Resolution of Approval 2019-12, duly adopted by the Planning Board on April 15, 2019 ("Site Plan Approval"); and

WHEREAS, in anticipation of the Developer closing title on the Property, the Developer and the Authority desire to enter into an agreement setting forth the rights, duties and obligations of the parties in connection with the construction of the water, sanitary sewer and fire service utility improvements related to said Development, including off-tract improvement obligations of the Developer.

NOW, THEREFORE, BE IT RESOLVED BY THE EAST WINDSOR MUNICIPAL UTILITIES AUTHORITY as follows:

 The EWMUA hereby approves the Capacity Allocation Agreement and Developer's On-tract and Off-tract Agreement with THE PLACE AT EAST WINDSOR, LLC, and

- The EWMUA directs the EWMUA Chairperson and Secretary to execute the Capacity Allocation Agreement and Developer's Ontract and Off-tract Agreement with THE PLACE AT EAST WINDSOR, LLC, and
- 3. The EWMUA further directs that a certified copy of this resolution be delivered to The New Jersey Department of Environmental Protection as evidence of its approval of the Development, and
- 4. The EWMUA further directs that the Executive Director shall take all necessary steps to expedite the directions specified in this resolution, as appropriate, and
- 5. This resolution shall take effect immediately.

With respect to any specific development, the Authority hereby conditions the above authorization upon the satisfaction by a Developer of all conditions precedent which are set forth in any related Board approved Developers Agreement, including but not limited to the payment of all fees and the conveyance of all necessary easements, to the satisfaction of the Authority's Executive Director, its General Manager, its Consulting Engineer and its Solicitor.

BE IT FURTHER RESOLVED that authorization from the East Windsor MUA Board for Authorization of Signatory take effective immediately.
