INDEPENDENT AUDITORS' REPORT

To the Honorable Board Members of East Windsor Municipal Utilities Authority

Report on the Audit of the Financial Statements

Opinion

We have audited the accompanying financial statements of the East Windsor Municipal Utilities Authority (the "Authority"), a component unit of the Township of East Windsor, as of and for the years ended November 30, 2024 and 2023, and the related notes to the financial statements, which comprise the Authority's basic financial statements as listed in the table of contents.

In our opinion, the financial statements referred to above present fairly, in all material respects, the financial position of the Authority as of November 30, 2024 and 2023, and the changes in financial position, and cash flows thereof for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS"), the standards applicable to financial audits contained in *Government Auditing Standards*, issued by the Comptroller General of the United States and audit requirements prescribed by the Division of Local Government Services, Department of Community Affairs, State of New Jersey. Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Authority, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Authority's ability to continue as a going concern for twelve months beyond the financial statement date, including any currently known information that may raise substantial doubt shortly thereafter.

INDEPENDENT AUDITORS' REPORT (CONTINUED)

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS, *Government Auditing Standards*, and audit requirements prescribed by the Division of Local Government Services, Department of Community Affairs, State of New Jersey, will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, *Government Auditing Standards*, and audit requirements prescribed by the Division of Local Government Services, Department of Community Affairs, State of New Jersey, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.
- identify and assess the risks of material misstatement of the financial statements, whether due
 to fraud or error, and design and perform audit procedures responsive to those risks. Such
 procedures include examining, on a test basis, evidence regarding the amounts and disclosures
 in the financial statements.
- obtain an understanding of internal control relevant to the audit in order to design audit
 procedures that are appropriate in the circumstances, but not for the purpose of expressing an
 opinion on the effectiveness of the Authority's internal control. Accordingly, no such opinion is
 expressed.
- evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Authority's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Required Supplementary Information

Accounting principles generally accepted in the United States of America require that the management's discussion and analysis and schedules of proportionate share of net pension liability and contributions, as listed in table of contents, be presented to supplement the basic financial statements. Such information is the responsibility of management and, although not a part of the basic financial statements, is required by the Governmental Accounting Standards Board who considers it to be an essential part of financial reporting for placing the basic financial statements in an appropriate operational, economic, or historical context. We have applied certain limited procedures to the required supplementary information in accordance with GAAS, which consisted of inquiries of management about the methods of preparing the information and comparing the information for consistency with management's responses to our inquiries, the basic financial statements, and other knowledge we obtained during our audit of the basic financial statements. We do not express an opinion or provide any assurance on the information because the limited procedures do not provide us with sufficient evidence to express an opinion or provide any assurance.

INDEPENDENT AUDITORS' REPORT (CONTINUED)

Supplementary Information

Our audit was conducted for the purpose of forming an opinion on the financial statements that comprise the Authority's basic financial statements. The accompanying budgetary comparison schedule and schedule of water and sewer revenue bonds, as listed in the table of contents, are presented for purposes of additional analysis and are not a required part of the basic financial statements. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the basic financial statements. The information has been subjected to the auditing procedures applied in the audit of the basic financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the basic financial statements or to the basic financial statements themselves, and other additional procedures in accordance with GAAS. The information marked "unaudited" has not been subjected to the auditing procedures applied in the audit of the basic financial statements, and accordingly, we do not express an opinion or provide any assurance on it. In our opinion, except for the portion marked "unaudited," the information is fairly stated, in all material respects, in relation to the basic financial statements as a whole.

Other Information

Management is responsible for the other information included in the financial statements. The other information comprises the roster of officials, as listed in the table of contents, but does not include the basic financial statements and our auditors' report thereon. Our opinion on the basic financial statements does not cover the other information, and we do not express an opinion or any form of assurance thereon.

In connection with our audit of the basic financial statements, our responsibility is to read the other information and consider whether a material inconsistency exists between the other information and the basic financial statements, or the other information otherwise appears to be materially misstated. If, based on the work performed, we conclude that an uncorrected material misstatement of the other information exists, we are required to describe it in our report.

Other Reporting Required by Government Auditing Standards

In accordance with *Government Auditing Standards*, we have also issued our report dated September 9, 2025, on our consideration of the Authority's internal control over financial reporting and on our tests of its compliance with certain provisions of laws, regulations, contracts and grant agreements, and other matters. The purpose of that report is solely to describe the scope of our testing of internal control over financial reporting and compliance and the results of that testing, and not to provide an opinion on the effectiveness of the Authority's internal control over financial reporting or on compliance. That report is an integral part of an audit performed in accordance with *Government Auditing Standards* in considering the Authority's internal control over financial reporting and compliance.

MANAGEMENT'S DISCUSSION AND ANALYSIS (UNAUDITED)

This section of the annual report presents management's analysis of the East Windsor Municipal Utilities Authority's (the "Authority") financial condition and activities for the year. This information should be read in conjunction with the Authority's financial statements.

Overview of Annual Financial Report

Management's Discussion and Analysis ("MD&A") serves as an introduction to, and should be read in conjunction with, the basic audited financial statements and supplemental information. The MD&A represents management's examination and analysis of the Authority's financial condition and performance. Summary financial statement data, key financial and operational indicators used in the Authority's capital plan, budget and other management tools were used for this analysis.

The financial statements report information about the Authority using full accrual accounting methods as utilized by similar business activities in the private sector. The financial statements include statements of net position; statements of revenues, expenses and changes in net position; statements of cash flows; and notes to the financial statements.

The statements of net position present the financial position of the Authority on a full accrual historical cost basis. The statements present the Authority's assets and liabilities, with the difference reported as net position. Net position increases and decreases over time are indicators of improving or deteriorating financial position of the Authority.

The statements of revenues, expenses and changes in net position present the results of the business activities over the fiscal year and information as to how net position changed during the fiscal year. All changes in net position are reported as soon as the underlying event giving rise to the change occurs, regardless of the timing of the related cash flows. These statements also provide information about the Authority's ability to recover its costs through user fees and other charges.

The statements of cash flows present changes in cash and cash equivalents resulting from operating activities, investing, capital and non-capital activities. The statements present cash receipts and disbursements without consideration of the earnings event. These statements show what sources provided cash, what cash was used for, and what the change in cash balance was for the reporting period.

The notes to the financial statements provide required disclosures and other information essential to a complete understanding of information provided in the financial statements. The notes contain information about the Authority's accounting policies, significant account balances and changes, material risks, obligations, commitments, contingencies and subsequent events.

Financial Highlights

2024

Total assets were \$68,110,556.23 and total liabilities were \$6,326,560.33, which together with deferred outflows of resources of \$854,583.00 and deferred inflows of resources of \$388,052.00, resulted in a net position of \$62,250,526.90 at November 30, 2024. Total net position decreased by \$1,344,342.22 from November 30, 2023, with unrestricted net position decreasing by \$2,040,517.13.

2024 (Continued)

The Authority had an operating loss of \$1,884,019.78 for the year ended November 30, 2024, compared to \$1,025,696.90 of operating loss for the year ended November 30, 2023.

The change in operating loss resulted from an increase of \$210,995.76 in operating revenues and an increase of \$1,069,318.64 in operating expenses.

The increase in operating revenues resulted from increases in user charges of \$221,926.34 (3.1%) and connection fees of \$48,060.00 (35.6%), offset by decreases in delinquent penalties of \$18,868.12 (49.4%) and other income of \$40,122.46 (9.2%).

Other income includes income from a shared service agreement with the Township of Cranbury for which the Authority maintains their sewer collection system of \$174,809.60, income from rental of space on cell towers of \$186,493.50, and miscellaneous income of \$33,475.44.

Cost of providing service expenses increased \$819,552.22 (15.0%) for the year ended November 30, 2024. Salaries and wages increased \$106,149.44 (5.4%) and employee benefits increased \$210,613.21 (26.5%). The increase in employee benefits for the year ended November 30, 2024, included increases in pension expense of \$138,698.00, medical insurance of \$49,486.00, and other insurance of \$8,058.00.

The cost of repairs and maintenance increased \$388,288.55 (50.7%). This increase included the cost of emergency repairs to Wyckoff Mills Road sewer lines of \$684,902.00, offset by decreases related to other projects.

The cost of contracted services decreased \$17,878.09 (2.7%).

Utility expenses increased \$55,798.14 (10.3%), including an increase of \$33,049.00 (26.8%) in electricity at the wastewater treatment plant. The solar energy credit we received was reduced by \$33,813.00 when compared to the year ended November 30, 2023.

Administrative and general expenses increased \$188,756.63 (17.2%) for the year ended November 30, 2024. Employee benefits increased \$70,746.31 (37.6%). The increase in employee benefits for the year ending November 30, 2024, included increases in pension expense of \$47,252.00, medical insurance of \$14,110.00, and other insurance of \$2,856.00.

Depreciation expense increased \$61,010.79 (2.8%).

The Authority's outstanding debt as of November 30, 2024, was \$264,648.39, a decrease of \$47,529.63 compared to November 30, 2023.

The Authority's net pension liability was \$4,423,862.00 and \$4,059,640.00 as of November 30, 2024 and 2023, respectively.

2023

Total assets were \$69,474,952.06 and total liabilities were \$5,836,824.94, which together with deferred outflows of resources of \$419,654.00 and deferred inflows of resources of \$462,912.00, resulted in a net position of \$63,594,869.12 at November 30, 2023. Total net position increased by \$240,724.96 from November 30, 2022, with unrestricted net position decreasing by \$829,754.29.

The Authority had an operating loss of \$1,025,696.90 for the year ended November 30, 2023, compared to \$163,891.09 of operating loss for the year ended November 30, 2022.

The change in operating loss resulted from an increase of \$110,761.51 in operating revenues and an increase of \$972,566.32 in operating expenses.

The increase in operating revenues resulted from increases in connection fees of \$115,105.00 (581.49%) and other income of \$56,538.19 (14.9%), offset by decreases in user charges of \$54,594.40 (0.76%) and delinquent penalties of \$6,288.28 (14.2%).

Other income includes income from a shared service agreement with the Township of Cranbury for which the Authority maintains their sewer collection system of \$159,329.73, income from rental of space on cell towers of \$174,366.94, and miscellaneous income of \$101,204.33.

Cost of providing service expenses increased \$1,015,387.49 (22.8%) for the year ended November 30, 2023. Salaries and wages increased \$323,772.76 (19.5%) and employee benefits increased \$379,351.87 (91.1%). The increase in employee benefits for the year ended November 30, 2023, included an increase in pension expense of \$213,738.00, an increase of \$115,995.00 in employee medical insurance, and an increase of \$34,347.00 in other employee insurances.

The cost of repairs and maintenance increased \$122,861.43 (22.6%). This increase included the cost of replacing the aerator riser at Well #7 of \$88,658.00 and repairs to Dutch Neck Road sewer lines of \$168,758, offset by decreases related to other projects.

The cost of contracted services increased \$180,735.06 (36.7%). Included in this increase was the cost of sludge disposal (hauling and treatment) which increased \$109,230.00 (29.65%).

Utility expenses increased overall by \$23,540.68 (4.5%) including an increase of \$20,218.00 (19.6%) in utilities at the wastewater treatment plant. The solar energy credit we received was reduced by \$33,803.00 when compared to the year ended November 30, 2022.

Administrative and general expenses increased \$109,385.20 (11.1%) for the year ended November 30, 2023. Employee benefits increased \$99,722.20 (112.8%). The increase in employee benefits for the year ended November 30, 2023, included an increase in pension expense of \$52,549.00, an increase of \$15,520.00 in employee medical insurance, and an increase of \$23,257.00 in other employee insurance coverages.

Depreciation expense decreased \$152,206.37 (6.5%).

The Authority's outstanding debt as of November 30, 2023, was \$312,178.02, a decrease of \$1,164,913.09 compared to November 30, 2022.

The Authority's net pension liability was \$4,059,640.00 and \$4,032,044.00 as of November 30, 2023 and 2022, respectively.

Net position may, over time, serve as a useful measure of the Authority's financial position. In the Authority's case, assets and deferred outflows of resources exceeded liabilities and deferred inflows of resources by \$62,250,526.90 at November 30, 2024, a decrease of \$1,344,342.22 from November 30, 2023.

The largest portion of the Authority's net position (\$55,175,071.69 or 88.6%) as of November 30, 2024, is reflected in its investment in capital assets, as shown in Table 1. These assets are used by the Authority to pump, treat, and deliver potable water and for the collection and treatment of wastewater and thus are not available for future spending.

Total net position decreased by \$1,344,342.22 from November 30, 2023, with unrestricted net position decreasing by \$2,040,517.13.

2023

Net position may, over time, serve as a useful measure of the Authority's financial position. In the Authority's case, assets and deferred outflows of resources exceeded liabilities and deferred inflows of resources by \$63,594,869.12 at November 30, 2023, an increase of \$240,724.96 for the fiscal year ended November 2023.

The largest portion of the Authority's net position (\$56,213,635 or 88.4%) as of November 30, 2023, is reflected in its investment in capital assets, as shown in Table 1. These assets are used by the Authority to pump, treat and deliver potable water and for the collection and treatment of wastewater and thus are not available for future spending.

Total net position increased by \$240,724.96 from November 30, 2022, with unrestricted net position decreasing by \$829,754.29.

Operating Activities

Table 2 summarizes the changes in revenues, expenses and net position for fiscal years November 30, 2024 and 2023.

The summary of revenues, expenses and changes in net position provides information as to the nature and source of changes in financial position. Table 2 shows that total revenues in 2024 decreased by \$595,593.28 (6.5%) and total expenses increased by \$989,473.90 (11.2%) compared to 2023.

Connection fees charged to new customers increased by \$48,060.00 (35.6%) when compared to 2023.

Other income decreased by \$58,990.58 (12.5%) compared to 2023.

Capital contributions paid by developers decreased \$859,765.00 (79.7%) compared to 2023.

Operating expenses increased \$1,069,318.64 (12.2%) compared to 2023.

The summary of revenues, expenses and changes in net position provides information as to the nature and source of changes in financial position. Table 2 shows that total revenues in 2023 increased by \$1,339,364.65 (17.3%) and total expenses increased by \$961,771.14 (12.2%) compared to 2022.

The items which were responsible for the major changes in net position for the year ended November 30, 2023, included:

Connection fees charged to new customers increased by \$115,105.00 (581.5%) when compared to 2022.

Other income increased \$50,249.91 (11.9%) compared to 2022.

Capital contributions paid by developers increased \$976,342.50 (957.3%) compared to 2022.

Operating expenses increased \$972,566.32 (12.5%) compared to 2022.

At November 30, 2023, the Authority's historical cost investment in capital assets was \$115,010,469.00, an increase of \$1,865,467.74 when compared to 2022.

The Authority's bonded debt was \$264,648.39 at November 30, 2024, a decrease of \$47,529.63 when compared to 2023. Interest on these bonds is paid semi-annually with interest rates from 0-5.5%. Principal payments on the outstanding debt are due annually with final maturity on August 1, 2029. Additional information on the Authority's long-term debt can be found in Note F in the financial statements.

2023

The Authority's bonded debt was \$312,178.02 at November 30, 2023, a decrease of \$1,164,913.09 when compared to 2022. Interest on these bonds is paid semi-annually with interest rates from 0-5.5%. Principal payments on the outstanding debt are due annually with final maturity on August 1, 2029. Additional information on the Authority's long-term debt can be found in Note F in the financial statements.

Next Year's Budget and User Rates

The Authority adopted an operating and maintenance budget of \$8,711,483.00 for fiscal year 2025, an increase of \$1,000,858.00 or (13.0%), compared to 2024 budget. Total user fee revenue was budgeted at \$8,917,016, an increase of \$1,660,792 or (22.9%) compared to the 2024 budget.

On February 20, 2025, the Authority approved increases to the fixed and variable water and sewer usage rates, effective March 1, 2025.

The Authority adopted a six-year capital program with their 2025 budget. The capital program includes future projects totaling \$72,795,000.00. The six-year capital program anticipates the use of \$3,655,000.00 from unrestricted net position to provide funding for anticipated projects.

NOTES TO FINANCIAL STATEMENTS

A. DESCRIPTION OF ENTITY

The East Windsor Municipal Utilities Authority (the "Authority") was created in 1965 by an ordinance of the Township of East Windsor (the "Township"), Mercer County, New Jersey, and is a public body politic and corporate of the State of New Jersey organized and existing pursuant to the Municipal Utilities Authority Law, constituting Chapter 183 of the Laws of 1957, of the State of New Jersey, as amended and supplemented.

The purposes for which the Authority was created include the acquisition and/or construction of plants and distribution systems to provide an adequate supply of water and the acquisition and/or construction of sewer facilities incident to the collection and treatment of sewerage for the relief of waters from pollution.

As a public body under existing statute, the Authority is exempt from both federal and state taxes.

The Governmental Accounting Standards Board ("GASB") Statement No. 14, *The Financial Reporting Entity,* requires that disclosure be made in the financial statements regarding the financial reporting entity of governmental units.

The financial reporting entity consists of the primary government, organizations for which the primary government is financially accountable, and other organizations for which the primary government is not accountable but for which the nature and significance of their relationship with the primary government are such that exclusion would cause the reporting entity's financial statements to be misleading or incomplete.

A component unit is a legally separate organization for which the elected officials of the primary government are financially accountable. The primary government is financially accountable if it appoints a voting majority of the organization's governing body, and either the primary government is able to impose its will on the organization or there is a potential for the organization to provide specific financial benefits to, or impose specific financial burdens on, the primary government.

The Authority is a component unit of the primary government, the Township. The board of the Authority is appointed by the committee of the Township and under the agreement entered into by the Authority and the Township, the Township will provide for deficits resulting from failure or inability of the Authority to derive adequate revenues from operating the systems.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation and Accounting

The Authority's financial statements are presented on the full accrual basis in accordance with accounting principles generally accepted in the United States of America.

In its accounting and financial reporting, the Authority follows the pronouncements of the GASB and other entities that promulgate accounting principles. GASB Statement No. 76, *The Hierarchy of Generally Accepted Accounting Principles for State and Local Governments*, establishes the order of priority of pronouncements and other sources of accounting and financial reporting guidance that a governmental entity should apply. Per the Statement, the sources of authoritative generally accepted accounting principles ("GAAP") are categorized in

descending order of authority as follows: GASB Statements and Interpretations, GASB Technical Bulletins, GASB Implementation Guides, and literature of the American Institute of Certified Public Accountants ("AICPA") cleared by the GASB. Authoritative GAAP is incorporated periodically into the Codification of Governmental Accounting and Financial Reporting Standards (Codification), and when presented in the Codification, it retains its authoritative status. If the accounting treatment for a transaction or other event is not specified within a source of authoritative GAAP described above, a governmental entity should first consider accounting principles for similar transactions or other events within a source of authoritative GAAP described above and then may consider non-authoritative accounting literature from other sources. These include GASB Concepts Statements; pronouncements and other literature of the Financial Accounting Standards Board ("FASB"), Federal Accounting Standards Advisory Board, International Public Sector Accounting Standards Board, and International Accounting Standards Board, and AICPA literature not cleared by the GASB; practices that are widely recognized and prevalent in the state and local government; literature of other professional associations or regulatory agencies; and accounting textbooks, handbooks and articles.

All activities of the Authority are accounted for within a single proprietary (enterprise) fund. Proprietary funds are used to account for operations that are: (a) financed and operated in a manner similar to private business enterprises where the intent of the governing body is that the cost (expenses, including depreciation) of providing goods or services to the general public on a continuing basis be financed or recovered primarily through user charges; or (b) where the governing body has decided that periodic determination of revenues earned, expenses incurred, and/or net income is appropriate for capital maintenance, public policy, management control, accountability, or other purposes.

The accounting and financial reporting treatment applied to the Authority is determined by its measurement focus. The transactions of the Authority are accounted for on a flow of economic resources measurement focus. With this measurement focus, all assets and all liabilities associated with the operations are included on the statements of net position. Net position (*i.e.*, total assets net of total liabilities) is segregated into "invested in capital assets, net of related bonds payable"; "restricted for capital improvements, for future debt service"; and "unrestricted" components. Water and sewer revenues are recognized based on usage, and connection fees are recognized upon issuance of permits. Expenses are recorded when incurred.

Cash and Cash Equivalents and Deposits

Cash and cash equivalents, for purposes of the statements of cash flows, include restricted and unrestricted cash on hand or on deposit, certificates of deposit, and investments with an original maturity of three months or less.

Investments

Investments include nonparticipating certificates of deposit that are stated at cost (which approximates market value). At November 30, 2024 and 2023, the Authority had investments in the amount of \$4,396,917.54 and \$4,109,484.36, respectively.

NOTES TO FINANCIAL STATEMENTS

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Restricted Assets

Restricted assets represent cash and cash equivalents maintained in accordance with bond resolutions, loan agreements and other resolutions and formal actions of the Authority or by agreement for the purpose of funding certain debt service payments, depreciation and contingency activities, and improvements and extensions to the utility systems.

Receivables

Customer receivables represent service fees earned, but not yet collected. User charges receivable as of November 30, 2024 and 2023, were \$1,350,476.84 and \$1,314,658.07, respectively.

Allowance for Doubtful Accounts

Management considers all user charges receivable to be fully collectible; thus no allowance for doubtful accounts is required. If amounts become uncollectible they will be charged to operations when that determination is made.

Capital Contributions

Developer impact fees are recorded in the period received due to the nature of the underlying developers' agreements. Developer financed construction in kind is recorded in the period in which applicable costs are incurred. Donated assets are recorded at fair market value at the time of the contribution. See Note I for total amounts to be received under the developers' agreements.

Capital Assets

Property, plant and equipment are stated at cost, which includes direct costs and other expenditures related to their acquisition.

System construction costs are charged to construction in progress until such time as given segments of the system are completed and put in operation.

Depreciation is determined on a straight-line basis for all property, plant and equipment.

The Authority capitalizes any of the above with a cost over \$5,000.

Bond Premium

Bond premium is amortized based on a pro-rata basis of the principal payments made, which approximates the effective interest method. Bond premium as of November 30, 2024 and 2023, was \$8,023.40 and \$9,710.80, respectively.

NOTES TO FINANCIAL STATEMENTS

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Budgets

Budgets, which are required by state statute, are adopted in accordance with regulations promulgated by the Department of Community Affairs ("DCA"). An annual appropriated budget is adopted for the operations of the Authority, subject to approval by the DCA. A capital program adopted by the Authority is management's six-year plan for financing the estimated cost of addition or replacement of major fixed assets used in the Authority's operation.

Net Position

Equity is classified as net position and displayed in three components:

- 1) Net Investment in Capital Assets consists of capital assets, net of accumulated depreciation and reduced by the outstanding balances of any debt that are attributable to the acquisition, construction, or improvement of those assets.
- 2) Restricted when constraints placed on net position are either a) externally imposed by creditors (such as the bond resolution), grantors, or laws or regulations of other governments, or b) imposed by law.
 - Presently, the Authority has two items of restricted net position which are required by the bond resolution. These restrictions are for capital improvements and future debt services.
- 3) <u>Unrestricted</u> any other net position that does not meet the definition of "restricted" or "net investment in capital assets."

Compensated Absences Payable

The Authority allows employees to earn vacation time based on the employee's length of service and time worked during the preceding year. No more than five unused vacation days may be carried forward to the following calendar year.

Unused sick leave may be carried forward into subsequent calendar years. Upon retirement, accumulated sick leave may be converted to a cash payment at a rate of not more than 50% of the employee's current hourly salary up to a maximum of \$15,000. If the employee leaves for a reason other than retirement, unused sick pay is forfeited.

It is estimated that the costs of unpaid vacation time and sick time as of November 30, 2024, are \$211,266.69 and \$81,803.74 respectively, and as of November 30, 2023, are \$221,578.55 and \$91,633.72, respectively.

Income Taxes

No provision for income taxes has been made, as the Authority is exempt from federal and state income taxes.

Unearned Revenue

Revenues received by the Authority before the earnings process has been completed are recorded as unearned revenue.

Adoption of Accounting Standards

The Authority has adopted the following pronouncements on the financial statements:

- GASB Statement No. 94 *Public-Private and Public-Public Partnerships and Availability Payment Arrangements*, effective for periods beginning after June 15, 2022. The adoption of this Statement had no effect on previously reported amounts.
- GASB Statement No. 96 Subscription-Based Information Technology Arrangements, effective for periods beginning after June 15, 2022. The adoption of this Statement had no effect on previously reported amounts.
- GASB Statement No. 97 Certain Component Unit Criteria, and Accounting and Financial Reporting for Internal Revenue Code Section 457 Deferred Compensation Plans, effective for periods beginning after June 15, 2022. The adoption of this Statement had no effect on previously reported amounts.
- GASB Statement No. 99 *Omnibus 2022*, certain requirements of which were effective for periods beginning after June 15, 2022 and June 15, 2023, respectively. The adoption of this Statement had no effect on previously reported amounts.
- GASB Statement No. 100 Accounting Changes and Error Corrections-an amendment of GASB Statement No. 62, effective for periods beginning after June 15, 2023. The adoption of this Statement had no effect on previously reported amounts.

Pending Accounting Standards

C. ROUNDING

Some amounts in the financial statements may have dollar differences due to rounding.

D. CASH AND CASH EQUIVALENTS AND INVESTMENTS

Cash and cash equivalents include petty cash, change funds, cash in banks, and all highly liquid investments with a maturity of three months or less at the time of purchase and are stated at cost which approximates fair value. U.S. Treasury and agency obligations and certificates of deposit with maturities of 90 days or less when purchased are stated at cost which approximate fair value. All other investments are stated at fair value.

Deposits

Cash and cash equivalents and investments include amounts on deposit, petty cash, change funds and short-term investments with original maturities of three months or less. New Jersey authorities are required by N.J.S.A. 40A:5-14 to deposit public funds in a bank or trust company having its place of business in the State of New Jersey and organized under the laws of the United States or of the State of New Jersey. N.J.S.A. 40A:5-15.1 provides a list of investments which may be purchased by New Jersey authorities. In addition, other state statutes permit investments in obligations issued by local authorities and other state agencies.

N.J.S.A. 17:9-41 et seq. establishes the requirements for the security of deposits of governmental units. The statute requires that no governmental unit shall deposit public funds in a public depository unless such funds are secured in accordance with the Governmental Unit Deposit Protection Act ("GUDPA"), a multiple financial institutional collateral pool, which was enacted in 1970 to protect governmental units from a loss of funds on deposit with a failed banking institution in New Jersey. Public depositories include state or federally chartered banks, savings banks or associations located in or having a branch office in the State of New Jersey, the deposits of which are federally insured.

Each depository participating in the GUDPA system must pledge collateral equal to at least 5% of the average amount of its public deposits and 100% of the average amount of its public funds in excess of the lesser of 75% of its capital funds or \$200 million. The minimum 5% pledge applies to institutions that are categorized as "well capitalized" by federal banking standards.

The percentage of the required pledge will increase for institutions that are less than "well capitalized".

GUDPA permits the deposit of public funds in the State of New Jersey Cash Management Fund or in institutions located in New Jersey that are insured by the Federal Deposit Insurance Corporation ("FDIC") or by any other agencies of the United States that insure deposits. GUDPA requires public depositories to maintain collateral for deposit of public funds that exceed insurance limits as follows:

No collateral is required for amounts covered by FDIC or National Credit Union Share Insurance Fund ("NCUSIF") insurance. The collateral which may be pledged to support these deposits includes obligations of the state and federal governments, insured securities and other collateral approved by the Department of Banking and Insurance ("DOBI"). When the capital position of the depository deteriorates or the depository takes an unusually large amount of public deposits, DOBI requires additional collateral to be pledged.

If a governmental depository fails and the FDIC or NCUSIF insurance does not insure or pay out the full amount of public deposits, the collateral pledged to protect these funds would first be

liquidated and paid out. If this amount is insufficient, other institutions holding public funds would be assessed pro rata up to 4% of their uninsured public funds. Although these protections do not constitute a 100% guarantee of the safety of all funds, no governmental unit under GUDPA has ever lost protected deposits.

Investments

N.J.S.A. 40A:5-15.1 provides that public funds may be invested in the following types of securities when authorized by resolution adopted by a majority vote of all its members:

- a. Bonds or other obligations of the United States of America or obligations guaranteed by the United States of America.
- b. Government Money Market Mutual Funds.
- c. Any obligation that a federal agency or a federal instrumentality has issued in accordance with an Act of Congress, which security has a maturity date not greater than 397 days from the date of purchase, provided that such obligation bears a fixed rate of interest not dependent on any index or other external factor.
- d. Bonds or other obligations of the Township, or bonds or other obligations of the school districts of which the Township is a part or within which the school district is located.
- e. Bonds or other obligations, having a maturity date of not more than 397 days from the date of purchase, that are approved by the New Jersey Department of Treasury, Division of Investments.
- f. Local Government Investment Pools.
- g. Deposits with the State of New Jersey Cash Management Fund established pursuant to Section 1 of P.L. 1977, C. 281 (C.52:18A:90.4).
- h. Agreements for the repurchase of fully collateralized securities if certain requirements apply.

N.J.S.A. 52:18A-90.4 provides that the Director of the Division of Investment may, subject to the approval of the State Investments Council and the State Treasurer, establish, maintain and operate a common trust fund to be known as the State of New Jersey Cash Management Fund in which may be deposited the surplus public monies of the state, its counties, municipalities and school districts and the agencies or authorities created by any of these entities. This fund shall be considered a legal depositor for public monies.

Certificates of deposit with original maturities in excess of ninety days are included in investments.

Custodial Credit Risk Related to Deposits (Continued)

Custodial credit risk is the risk that, in the event of a bank failure, the government's deposits may not be returned to it. Although the Authority does not have a formal policy for custodial credit risk, other than those policies that adhere to the requirements of statute, N.J.S.A. 17:9-41 et seq. requires that governmental units shall deposit public funds in public depositories protected from loss under the provisions of GUDPA. Under the Act, the first \$250,000 of governmental deposits in each insured depository is protected by the FDIC. Public funds owned by the Authority in excess of FDIC insured amounts are protected by GUDPA. However, GUDPA does not protect intermingled trust funds such as salary withholdings and funds that may pass to the Authority relative to the happening of a future condition. Such funds are shown as Uninsured and Uncollateralized in the schedule below.

F. LONG-TERM DEBT

The Authority issues revenue bonds to provide funds for the acquisition and construction of capital facilities. Revenue bonds currently outstanding are as follows:

Series 2009 Subordinated Revenue Bonds – On November 6, 2008, loan agreements were executed between the State of New Jersey, acting by and through the New Jersey Department of Environmental Protection and the New Jersey Environmental Infrastructure Trust whereby commitments were made for the Authority to have loans not to exceed \$29,666,220.00. The loan agreements contain provisions for repayment during the years 2011 through 2023. Provision has been made for the capitalization of interest for the first twenty-two months of all bonds issued. The interest rate for the New Jersey Environmental Infrastructure Trust portion of the loans (\$16,980,000.00) ranges between 5.00% and 5.50%, no interest is paid on the Fund portion of the loans (\$12,686,220.00).

The Authority received notice in a letter dated February 12, 2014, from the State of New Jersey Department of Environmental Protection that the remaining fund share of the loan in the amount of \$2,650,076.00 would be de-obligated and that pursuant to P.L. 2008 Chapter 68, appropriated application to reduce the amount of fund loan for this project would be made by the Commissioner of the New Jersey Department of Environmental Protection. Included with this letter was a revised fund loan repayment schedule reducing the loan payment for August 1, 2020, by \$298,842.28 and eliminating total payments from February 1, 2021 through August 1, 2023, in the amount of \$2,351,233.72.

In addition, the Authority received another notification from the New Jersey Environmental Infrastructure Trust dated August 5, 2014, stating that the Authority had received on February 12, 2014, notification of a final loan decrease from the Department of Environmental Protection based upon project completion. The notice indicated that in accordance with section 5.02(4)(a) of the Bond Resolution, the remaining funds in the East Windsor Municipal Utilities Loan Account were included in a current defeasance completed on July 18, 2014, by the New Jersey Environmental Infrastructure Trust.

Included with this notice was a revised trust loan repayment schedule reducing the future principal payments on August 1, 2021, by \$730,000.00, August 1, 2022, by \$900,000.00, and August 1, 2023, by \$950,000.00 for a total reduction of \$2,580,000.00.

Funds in the amount of \$3,058,433.66 were deposited in the Defeasance account established with The Bank of New York Mellon, as Trustee. These funds shall be invested (in securities which are state and local government securities) and transferred to the Debt Service Fund in the amounts and at times set forth in accordance with section 5.02(4)(a) of the Bond Resolution.

Series 2010 Subordinated Revenue Bonds - On March 10, 2010, loan agreements were executed between the State of New Jersey, acting by and through the New Jersey Department of Environmental Protection and the New Jersey Environmental Infrastructure Trust whereby commitments were made for the Authority to have loans not to exceed \$889,220.00. In addition to the loan amounts, the Authority was awarded \$878,440.00 in a Federal Stimulus Grant under the American Recovery and Reinvestment Act of 2009. The funds will be used for improvements and upgrades to the Millstone Road Water Pollution Control Facility. The loan agreements contain provisions for repayment during the years 2011 through 2029. Provision has been made for the capitalization of interest for the first twenty-two months of all bonds issued. The interest rate for the New Jersey Environmental Infrastructure Trust portion of the loan (\$450,000.00), ranges between 3.00% to 5.00%, no interest is paid on the Fund portion of the loans totaling \$439,200.00. On May 10, 2016, the New Jersey Environmental Infrastructure Trust issued Series 2016A-R1 (2008A Financing Program) Refunding Bonds. \$586,106.42 was established as deferred loss on refunding upon the advance refunding and defeasance of \$8,827,000 of Series 2008A Bonds through the issuance of \$7,607,000 Refunding Series 2016A-R1 Bonds. G. PENSION PLAN

Simplified Employee Pension Plan

The Authority has a Simplified Employee Pension Plan ("SEP") available for all its employees. Employees are 100% vested in the SEP/IRA contribution at all times. The Authority did not make contributions to the plan in 2024 or 2023.

Pension and Retirement Plan

The Authority's employees participate in the following defined benefit pension plan: the Public Employees' Retirement System ("PERS"), which is administered by the State of New Jersey, Division of Pensions and Benefits (the "Division"). The plan has a board of trustees that is primarily

Plan Description

PERS is a cost-sharing multiple-employer defined benefit pension plan which was established as of January 1, 1955. For additional information about PERS, please refer to Division's Annual Comprehensive Financial Report (ACFR) which can be found at www.state.nj.us/treasury/pensions/annrprts.shtml

Benefits Provided

The vesting and benefit provisions are set by N.J.S.A. 43:15A. PERS provides retirement, death and disability benefits. All benefits are vested after ten years of service, except for medical benefits, which are vested after 25 years of service or under the disability provisions of PERS.

1 Members who were enrolled prior to July 1, 2007

Service retirement benefits of 1/55th of final average salary for each year of service credit are available to Tiers 1 and 2 members upon reaching age 60, and to Tier 3 members upon reaching age 62. Service retirement benefits of 1/60th of final average salary for each year of service credit are available to Tier 4 members upon reaching age 62, and Tier 5 members upon reaching age 65. Early retirement benefits are available to Tiers 1 and 2 members before reaching age 60, Tiers 3 and 4 before age 62 with 25 or more years of service credit, and Tier 5 members with 30 or more years of service credit before age 65. Benefits are reduced by a fraction of a percent for each month that a member retires prior to the age at which a member can receive full early retirement benefits in accordance with their respective tier. Tier 1 members can receive an unreduced benefit from age 55 to age 60 if they have at least 25 years of service. Deferred retirement is available to members who have at least 10 years of service credit and have not reached the service retirement age for their respective tier.

Contributions

The contribution requirements of PERS plan members are determined by state statute. In accordance with Chapter 62, P.L. 1994, plan members enrolled in the PERS were required to contribute 5.00% of their annual covered salary. Effective July 1, 2008, however, in accordance with Chapter 92, P.L. 2007 and Chapter 103, P.L. 2007, plan members are required to contribute 5.50% of their annual covered salary. For employees enrolled in the retirement system prior to July 1, 2008, the increase is effective with the payroll period that begins immediately after July 1, 2008. Pursuant

to the provisions of Chapter 78, P.L. 2011, the active member contribution rate increased to 6.50% plus an additional 1.00% phased-in over seven years. The phase-in of the additional incremental member contribution amount began July 1, 2012, and increases each subsequent July 1. The active member effective contribution rates were July 1, 2018, 7.5%; July 1, 2017, 7.34%; July 1, 2016, 7.20%; July 1, 2015, 7.06%; and July 1, 2014, 6.92%. The State Treasurer has the right under the current law to make temporary reductions in member rates based on the existence of surplus pension assets in the retirement system; however, the statute also requires the return to the normal rate when such surplus pension assets no longer exist.

The Authority is billed annually for its normal contribution plus any accrued liability. Contributions to PERS from the Authority were \$443,010.00 and \$374,598.00 for the years ended November 30, 2024 and 2023, respectively.

Special Funding Situation

A special funding situation exists for the local employers of the Public Employees' Retirement System of New Jersey. The State of New Jersey, as a non-employer, is required to pay the additional costs incurred by local employers under Chapter 133, P.L. 2001. The special funding situation for Chapter 133, P.L. 2001 is due to the State paying the additional normal cost related to benefit improvements from Chapter 133. Previously, this additional normal cost was paid from the Benefit Enhancement Fund (BEF). As of June 30, 2024, there is no net pension liability associated with this special funding situation and there was no accumulated difference between the annual additional normal cost under the special funding situation and the actual State contribution through the valuation date. The state special funding situation pension expense of \$43,606,492, for the fiscal year ended June 30, 2024, is the actuarially determined contribution amount that the State owes for the fiscal year ended June 30, 2024. The pension expense is deemed to be a state administrative expense due to the special funding situation. The portion of the non-employer contributing entities' total proportionate share of the collective net pension liability that is associated with the Authority is \$0 and the total proportionate share of the employer pension benefit is \$14,263 for the June 30, 2024, measurement date.

<u>Pension Liabilities, Pension Expense, and Deferred Outflows of Resources and Deferred Inflows of Resources Related to Pensions</u>

For the years ended November 30, 2024 and 2023, the Authority had a liability of \$4,423,862.00 and \$4,059,639.60, respectively, for its proportionate share of the net pension liability in PERS. The net pension liability was measured as of June 30, 2024, and the total pension liability used to calculate the net pension liability was determined by an actuarial valuation as of that date. The Authority's proportion of the net pension liability was based on a projection of the Authority's long-term share of contributions to the pension plan relative to the projected contributions of all participating members of the plan, actuarial determined. As of the June 30, 2024 and 2023, measurement dates the Authority's proportion was 0.0325570174% and 0.0280277112%, respectively, which was an increase of .005% from its proportion measured as of June 30, 2022, respectively. The actuarial assumptions used in the July 1, 2023, valuation were based on the results of an actuarial experience study for the period July 1, 2018 to June 30, 2021. It is likely that future experience will not exactly conform to these assumptions. To the extent that actual experience deviates from these assumptions the emerging liability may be higher or lower than anticipated. The more the expectation deviates, the larger the impact on future financial statements.

Long-Term Rate of Return

In accordance with State statute, the long-term expected rate of return on plan investments (7.00% at June 30, 2024 and 2023), is determined by the State Treasurer, after consultation with the directors of the Division of Investments and Division of Pensions and Benefits, the board of trustees, and the actuaries. The long-term expected rate of return was determined using a building block method in which best-estimate ranges of expected future real rates of return (expected returns, net of pension plan investment expense and inflation) are developed for each major asset class. These ranges are combined to produce the long-term expected rate of return by weighting the expected future real rates of return by the target asset allocation percentage and by adding expected inflation. Best estimates of arithmetic real rates of return for each major asset class included in PERS's target asset allocation as of June 30, 2024 and 2023, are summarized in the following tables:

Discount Rate

The discount rate used to measure the pension liabilities of PERS was 7.00% as of June 30, 2024 and 2023. The projection of cash flows used to determine the discount rate assumed that contributions from plan members will be made at the current member contribution rates and that contributions from employers and the nonemployer contributing entity will be based on 100% of the actuarially determined contributions for the State employer and 100% of actuarially determined contributions for the local employers. Based on those assumptions, the plan's fiduciary net position was projected to be available to make all projected future payments of current plan members. Therefore, the long-term expected rate of return on plan investments was applied to all projected benefit payments in determining the total pension liability.

In accordance with terms of the Service Contract dated June 1, 1965, as amended, between the Authority and the Township, the Township will pay service charges to the Authority of a sum equal to the excess (if any) of all expenditures of the water/sewer fund of the Authority over water/sewer fund receipts of the Authority for any fiscal year.

No amounts have been accrued or paid by the Township to the Authority under the terms of the service contract through the fiscal years ended November 30, 2024 and 2023.

I. DEVELOPERS' AGREEMENTS (WATER AND SEWER FACILITIES TRUST ACCOUNT)

The Authority has negotiated Capacity Allocation and Developer's On-Tract and Off-Tract Agreements and an Agreement for Payment in Lieu of Construction of a Satellite Treatment Plant with various developers. The Authority will receive a total of \$14,745,212.98 of cash and construction in kind, with respect to these agreements. As of November 30, 2024 and 2023, the Authority had received \$13,923,203.85 and \$13,704,635.85, respectively, in cash and construction in kind. These funds are restricted for capital improvements. Cash restricted for capital improvements at November 30, 2024 and 2023, is \$3,221,448.40 and \$1,484,150.48, respectively.

J. RISK MANAGEMENT

The Authority is exposed to various risks of losses related to torts, theft of, damage to and destruction of assets; errors and omissions; injuries to employees; and natural disasters. The Authority carries commercial insurance for all risks. Settled claims resulting from these risks have not exceeded commercial insurance coverage in any of the past three fiscal years. There was no reduction in commercial coverage during the year.

NOTES TO FINANCIAL STATEMENTS

K. LITIGATION

As of November 30, 2024, the Authority was not a party to pending litigation or legal matters that would potentially have a material adverse effect on the financial position of the Authority in the event of an unfavorable or adverse outcome.

L. CONSTRUCTION COMMITMENTS

On January 28, 2021, the Authority awarded a contract to Uni-tech Drilling Co. Inc., 61 Grays Ferry Road, Franklinville, NJ 08322 in the amount of \$547,659.00 for the construction of new Well #6R and a new well pump. The contractor began work on this contract in February 2021. Payments were made in the amount of \$517,990.21 as of November 30, 2022. The final payment in the amount of \$29,668.79 was made on February 16, 2023.

On December 16, 2021, the Authority awarded a contract to A.C. Schultes, 664 So. Evergreen Avenue, Woodbury NJ 08096 in the amount of \$344,525.00 for the drilling of a test well and geophysics sampling of the soil (Well #9). The contractor began work on this contract in January 2022. Payments have been made in the amount of \$215,995.00 as of November 30, 2024. No additional payments have been made as of the date of this report, leaving a balance of \$128,530.00.

On February 16, 2023, a contract was awarded by the Authority to A.C. Schultes, 664 So. Evergreen Avenue, Woodbury, NJ 08096 in the amount of \$602,200.00 to furnish material and equipment for the construction of new Well #10. The contractor began work on this contract in June 2023. Payments have been made in the amount of \$408,100.00 as of the date of this report, leaving a balance of \$194,100.00.

M. SUBSEQUENT EVENT

On February 20, 2025, the Authority approved increases to the fixed and variable water and sewer usage rates, effective March 1, 2025. The increases are expected to have a significant impact on the user charge revenues earned by the Authority.
