Chairperson Moore requested that the Public Notice be read. The secretary read the statement stating that the agenda for this meeting was e-mailed to the Cranbury Press-Windsor Hights Herald, Trenton Times, and Trentonian on Tuesday November 4, 2025. An agenda was posted on the official bulletin board of the Authority and delivered to the Township Clerk for posting on the bulletin board at the East Windsor Township Municipal Complex on Friday, November 7, 2025. Chairperson Moore then asked for a roll call after which she asked if any member had any objection to holding this meeting as advertised. No one objected.

Chairperson Moore asked if there is anyone from the public who would like to speak on any issue not on today's agenda. Hearing no one, Chairperson Moore closed the public portion of the meeting.

Chairperson Moore asked for approval of Resolution #2025-53 Authorizing the Use of EWMUA's Emergency Sewer Repair Contractor for Cranbury. Steve Kurs made the motion, seconded by Lew Meixler and unanimously carried.

**AUTHORIZING THE USE OF EWMUA'S EMERGENCY SEWER REPAIR  
CONTRACTOR FOR CRANBURY TWP**

**WHEREAS**, the East Windsor Municipal Utilities Authority ("Authority") entered into a Shared Services Agreement with the Township of Cranbury, effective January 1, 2024 through December 31, 2026, to provide regular and emergency operation and maintenance for its sanitary sewer system, including pump stations and infrastructure; and

**WHEREAS**, the Township of Cranbury is in need of emergency sewer repairs to its infrastructure; and

**WHEREAS**, the Authority has a two (2) year contract for emergency sewer repairs that was awarded to J. Fletcher Creamer & Son, Inc. on November 21, 2024 (Resolution 2024-37) for time and material fees not to exceed eighty-eight thousand eight hundred twenty dollars and eighty cents (\$88,820.80) for the first year 2024-2025 and eighty-eight thousand eight hundred twenty dollars and eighty cents (\$88,820.80) for second year 2025-2026; and

**WHEREAS**, the Township of Cranbury desires to utilize the Authority's emergency sewer repairs contract with J. Fletcher Creamer & Son, Inc. to repair its infrastructure and has agreed to reimburse the Authority for all repairs incurred and invoiced.


**NOW, THEREFORE BE IT RESOLVED**, that the East Windsor Municipal Utilities Authority authorizes the Executive Director to contract with J. Fletcher Creamer & Son, Inc. on behalf of the Township of Cranbury and to bill the Township for all invoices incurred and paid.

**WHEREAS**, the Developer has satisfactorily performed and repaired a test pit, as required; and,

**WHEREAS**, the EWMUA desires to release the aforementioned cash performance guarantee subject, which shall be more fully described hereinafter.

**NOW, THEREFORE, BE IT RESOLVED** by the East Windsor Municipal Utilities Authority, County of Mercer, State of New Jersey, as follows:

**RESOLUTION ACCEPTING A BID AND AWARDING A CONTRACT TO FREEHOLD  
CARTAGE, INC. FOR THE PROVISION OF SLUDGE HAULING SERVICE**

**WHEREAS**, the East Windsor Municipal Utilities Authority (EWMUA) went to public notification to accept bids for the purpose of Sludge Hauling Services on **October 8, 2025**; and

**WHEREAS**, in accordance with a properly advertised Notice to Bidders, four (4) sealed bids were received on October 28, 2025 at 10:00 am by the Qualified Purchasing Agent for the provision of Sludge Hauling Services for a period of two (2) years (November 1, 2025 – October 31, 2027) with an option to extend the contract for two (2) additional 12-month periods; and

**WHEREAS**, after review of the bids submitted there was one (1) low bidder:

**Freehold Cartage, Inc.**, PO Box 5010, Freehold, NJ 07728-5010 for the provision of Sludge Hauling Services from the EWMUA to Stony Brook RSA at \$0.056 per gallon in year one (1) and \$0.056 per gallon in year two (2), and to Somerset Raritan Valley Sewerage Authority at \$0.079 per gallon in year one (1) and \$0.079 per gallon in year two (2).

**WHEREAS**, it is the recommendation of the Executive Director that Freehold Cartage, Inc. be accepted as the lowest, responsible, responsive bidder complying with the terms and specifications, and be awarded the contract for the provision of Sludge Hauling Service for two (2) years with an option to extend the contract for two (2) additional 12-month periods; and

**WHEREAS**, funds in an amount not to exceed \$300,000.00 in year one and \$300,000.00 in year two have been certified by the Chief Financial Officer to be available in the following account number: 01-401-6218 upon the adoption of the FY 2026 and 2027 budgets.

**NOW, THEREFORE BE IT RESOLVED** by the governing body of the East Windsor Municipal Utilities Authority as follows:

The bid of Freehold Cartage, Inc., PO Box 5010, Freehold, NJ 07728-5010 for the provision of Sludge Hauling Service from EWMUA to Stony Brook RSA and Somerset Raritan Valley Sewerage Authority is hereby accepted and the contract awarded for two (2) years with an option to extend for two (2) additional 12-month periods. 

**AUTHORIZING THE AWARD OF A CONTRACT TO NATIONAL AUTO FLEET VIA  
THE SOURCEWELL CONTRACT NO. 091521-NAF FOR TWO (2) NEW 2026 FORD  
BRONCO SPORT (R9D) BADLANDS, 4X4**

**WHEREAS**, the Maintenance Department recommends the East Windsor Municipal Utilities Authority ("Authority") procure two (2) new 2026 Ford Bronco Sport (R9D) Badlands, 4X4 to be utilized by the Administration Department; and

**WHEREAS**, the Maintenance Department has researched vendors that would achieve the Authority's goals and determined that the vehicle may be procured through a nationally recognized and accepted cooperative purchasing contract in effect until November 8, 2026 between Sourcewell [formerly known as National Joint Powers Alliance ("NJPA")] and National Auto Fleet Group; and

**WHEREAS**, the Authority is a member of the Sourcewell cooperative (account number 91084); and

**WHEREAS**, pursuant to N.J.S.A. 52:34-6.2b.(3) (as amended by P.L. 2011, c. 139) and LFN 2012-10, a local unit may purchase goods and services without public bidding under the Local Public Contracts Law through the use of a nationally-recognized and accepted cooperative purchasing contract that has been developed utilizing a competitive bidding or contracting process by another contracting unit within New Jersey or another state; and

**WHEREAS**, Sourcewell is a regional organization of governmental units operating under the laws of the State of Minnesota and is itself a government corporation and agency pursuant to the laws of Minnesota; and

**WHEREAS**, the subject cooperative purchasing contract was awarded by then NJPA to National Auto Fleet Group utilizing a competitive contracting process; and

**WHEREAS**, also pursuant to N.J.S.A. 52:34-6.2.(3) (as amended by P.L. 2011, c. 139), and LFN 2012-10, prior to making purchases under nationally-recognized and accepted cooperative purchasing contracts, the local unit must determine that the use of the cooperative purchasing contract shall result in cost savings after all factors, including charges for service, material, and delivery have been considered; and


**WHEREAS**, the Maintenance Department has determined that use of the Sourcewell cooperative purchasing contract to procure the vehicle will result in cost savings to the Authority; and

**WHEREAS**, consistent with the Sourcewell cooperative purchasing contract and needs of the Authority, National Auto Fleet Group has submitted a proposal to provide two (2) new 2026 Ford Bronco Sport (R9D) Badlands, 4X4 for use by the Authority for the sum of \$82,642.20; and

**WHEREAS**, the Chief Financial Officer has certified that sufficient funds are available upon the adoption of the FY 2026 budget for this purchase in account 01-301-6803 Vehicle Purchases in the amount of \$41,321.10, and account 01-401-6803 Vehicle Purchases in the amount of \$41,321.10.

**NOW, THEREFORE, BE IT RESOLVED**, that the governing body of the East Windsor Municipal Utilities Authority, County of Mercer, hereby awards a contract to the National Auto Fleet Group for the purchase of two (2) new 2026 Ford Bronco Sport (R9D) Badlands, 4X4 for use by the Authority for the sum of \$82,642.20.

**WHEREAS**, the East Windsor Municipal Utilities Authority (EWMUA) has a standing requirement for the installation of outdoor meter pits when installing an additional meter/irrigation meter at existing residential properties; and


**WHEREAS**, the Executive Director has reviewed data concerning cost burdens on property owners that make adherence to this requirement challenging or impractical at this time; and

**WHEREAS**, the Board has determined that a two (2) year temporary suspension of the outdoor meter pit requirement for existing residential customers is in the best interest of the EWMUA and its customers to mitigate current challenges without compromising service;

**NOW, THEREFORE, BE IT RESOLVED**, that the Board of Directors of East Windsor Municipal Utilities Authority hereby approves a temporary suspension of the requirement for the installation of outdoor meter pits for existing residential users for a period of two (2) years, effective November 12, 2025 and continuing until November 11, 2027; and



**AUTHORIZING A CHANGE ORDER FOR THE MONITORING WELLS CONTRACT 2025-40**

**WHEREAS**, the Board of Directors (the "Board") of East Windsor Municipal Utilities Authority (the "EWMUA") previously approved and entered into an agreement (the "Original Agreement") with DN Drilling on September 18, 2025 for Construction of Monitoring Wells and Aquifer Tests; and

**WHEREAS**, the Original Agreement is identified as Contract No. 2025-40 and has an initial total value not to exceed \$78,962.00;

**WHEREAS**, it has become necessary to modify the scope of work due to actual well depths exceeding the specified depths, resulting in an additional 118 feet of drilling, additional day rates for installation and development, and the need for protective casings and cement;

**WHEREAS**, the Change Order will result in a net increase of \$15,324 to the Original Agreement, bringing the revised total contract value to an amount not to exceed \$94,286.00;

**WHEREAS**, the Board has reviewed the terms and implications of the proposed Change Order and determined that it is in the best interest of the EWMUA;


